The Options Clearing Corporation ("OCC") has been advised that Apple Inc. (AAPL) has announced a 7 for 1 stock split. The Ex-distribution Date is June 9, 2014. The Payable Date is June 6, 2014. The Record Date is June 2, 2014.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Apple Inc. Futures will be adjusted as follows:

CONTRACT ADJUSTMENT

Effective Date: June 9, 2014

Futures Symbols: Unchanged

Number of Contracts: Multiplied by 7

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 7 and rounding to four decimal places.

For example:

New Deliverable per Contract: 100 Apple Inc. (AAPL) Common Shares
