The Options Clearing Corporation (OCC) has been advised that Vistaprint N.V. (VPRT) will change its name, trading symbol and CUSIP to Cimpress N.V. (CMPR), CUSIP N20146101. As a result, option symbol VPRT will also change to CMPR effective at the opening of business on November 17, 2014.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CMPR commencing November 17, 2014.
