Amyris, Inc. (AMRS) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each AMRS Common Share will be converted into the right to receive approximately 0.066667 (New) Amyris, Inc. Common Shares. Fractional AMRS shares will be rounded up to the next whole share. The reverse stock split will become effective before the market open on June 6, 2017.
