PRICING

The underlying price for the AGU2D Futures contract deliverables, expressed in term of current market value, would be calculated as follows:

Please note that the valuation would apply only to the AGU2D futures deliverable in terms of current market value of the deliverable securities. BACKGROUND

On November 3, 2016, Shareholders of Agrium Inc. (AGU) voted concerning the proposed merger with Potash Corporation of Saskatchewan Inc. (POT), to form a new company named Nutrien Ltd. The merger was approved and consummated before the open on January 2, 2018. As a result, each existing AGU Common Share will be converted into the right to receive 2.23 (New) Nutrien Ltd. Common Shares.

Nutrien Ltd. Common Shares will begin trading on January 2, 2018, on the New York Stock Exchange, under the trading symbol "NTR."
