On June 27, 2019, Shareholders of WABCO Holdings Inc. (WBC) will vote concerning the proposed merger with Verona Merger Sub Corporation, a wholly-owned subsidiary of ZF Friedrichshafen AG. If the merger is approved and consummated, each existing WBC Common Share will be converted into the right to receive \$136.50 net cash per share.

CONTRACT ADJUSTMENT

DATE: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in early 2020.

MULTIPLIER: 100 (e.g. 1.00 equals \$100)

**NEW DELIVERABLE
PER CONTRACT:** \$13,650.00 Cash (\$136.50 x 100)

Settlement in WBC1D futures will take place through OCC's cash settlement system.

Pursuant to Rule 1304 of OCC's Rules and Bylaws, the maturity date for all WBC1D Security Futures will be accelerated on a date to be determined.
