On June 12, 2025, Shareholders of Dun & Bradstreet Holdings, Inc. (DNB) will vote concerning the proposed merger with a wholly owned subsidiary of Denali Intermediate Holdings, Inc., which are both subsidiaries of certain investment funds managed by affiliates of Clearlake Capital Group L.P. If the merger is approved and consummated, each existing DNB Common Share will be converted into the right to receive \$9.15 net cash per share.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur during the third quarter of 2025.

**New Deliverable
Per Contract:** \$915.00 Cash (\$9.15 x 100)

Settlement in DNB options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
