On June 27, 2025, Direxion Shares ETF Trust announced that it would terminate and subsequently liquidate the Direxion Daily Cloud Computing Bull 2X Shares (CLDL). CLDL shares ceased trading on the NYSE Arca, Inc. at the close of regular trading on July 24, 2025. **Proceeds of the liquidation were distributed to shareholders in the amount of \$14.13214 per CLDL share on July 30, 2025.** 

## **Contract Adjustment**

The option symbol CLDL will not change.

New Deliverable

Per Contract: \$1,413.21 Cash (\$14.13214 x 100)

CLDL options, which were subject to delayed settlement from July 25, 2025 through July 29, 2025, will no longer be subject to delayed settlement, effective July 30, 2025.

Settlement in CLDL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Direxion Daily Cloud Computing Bull 2X Shares options whose expiration dates are after 08-15-2025 will have their expiration dates advanced to 08-15-2025. Expiration dates occurring before 08-15-2025 (e.g., Flex options) will remain unchanged.

All Direxion Daily Cloud Computing Bull 2X Shares options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 08-15-2025

Existing American-style Direxion Daily Cloud Computing Bull 2X Shares options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
