Subject: NV5 Global, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: TIC1

NV5 Global, Inc. options were adjusted on August 4, 2025 (See OCC Information Memo #57018). The new deliverable became 1) 115 Acuren Corporation (TIC) Common Shares, 2) Cash in lieu of 0.23 fractional TIC shares, and 3) \$1,000.00 Cash. Only settlement of the cash portion of TIC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$11.2817 per whole TIC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.23 \times \$11.2817 = \$2.59 \text{ per TIC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 4, 2025 through August 08, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the TIC1 options are as follows:

New Deliverable

Per Contract: 1) 115 Acuren Corporation (TIC) Common Shares
2) \$1,002.59 Cash (\$1,000.00 + \$2.59)

Strike Prices: Unchanged

CUSIP: TIC: 00510N102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The TIC component of TIC1 exercise/assignment activity from August 4, 2025 through August 7, 2025, has settled through National Security Clearing Corporation (NSCC). The \$1,002.59 cash amount will be settled by OCC.

Pricing

The underlying price for TIC1 will be determined as follows:

$$\text{TIC1} = 1.15 (\text{TIC}) + 10.0259$$

For example, if TIC closes at 9.71, the TIC1 price would be calculated as follows:

$$\text{TIC1} = 1.15 (9.71) + 10.0259 = 21.19$$
