The Options Clearing Corporation ("OCC") has been advised that MasterCard Incorporated (MA) has announced a 10 for 1 stock split. The Ex-distribution Date is January 22, 2014. The Payable Date is January 21, 2014. The Record Date is January 9, 2014.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all MasterCard Incorporated Futures will be adjusted as follows:
