The Options Clearing Corporation ("OCC") has been advised that Sunoco Logistics Partners L.P. (SXL) has announced a 2 for 1 stock split. The Ex-distribution Date is June 13, 2014. The Mail Date is June 12, 2014. The Record Date is June 5, 2014.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Sunoco Logistics Partners L.P. Futures will be adjusted as follows:
