The Options Clearing Corporation (OCC) has been advised that Sesa Sterlite Limited (SSLT) will change its name, trading symbol and CUSIP to Vedanta Limited (VEDL), CUSIP 92242Y100. As a result, option symbol SSLT will also change to VEDL effective at the opening of business on May 11, 2015.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol VEDL commencing May 11, 2015.
