### SUBJECT: ISHARES SHORT-TERM CORPORATE BOND ETF - 2 FOR 1 STOCK SPLIT OPTION SYMBOL: IGSB EX-DATE: 8/8/18

iShares Short-Term Corporate Bond ETF (IGSB) has announced a 2 for 1 stock split. The Ex-distribution Date is August 8, 2018. The Payable Date is August 7, 2018. The Record Date is August 3, 2018.

Pursuant to Article VI, Section 11A, of OCC's By-Laws, all iShares Short-Term Corporate Bond ETF options will be adjusted as follows:
