Eldorado Gold Corporation (EGO) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each EGO Common Share will be converted into the right to receive 0.20 (New) Eldorado Gold Corporation Common Shares. The reverse stock split will become effective before the market open on December 31, 2018.
