Zafgen, Inc. (ZFGN) has announced a 1-for- 12 reverse stock split and name/symbol/CUSIP change. As a result of the reverse stock split and name/symbol/CUSIP change, each ZFGN Common Share will be converted into the right to receive approximately 0.083333 (New) Larimar Therapeutics, Inc. (LRMR) Common Shares. The reverse stock split and name/symbol/CUSIP change will become effective before the market open on May 29, 2020. Cash will be paid in lieu of fractional shares.

DELAYED SETTLEMENT

The LRMR component of the LRMR1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the LRMR1 deliverable until the cash in lieu of

fractional LRMR Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
