On June 27, 2019, Shareholders of WABCO Holdings Inc. (WBC) voted concerning the proposed merger with Verona Merger Sub Corporation, a wholly-owned subsidiary of ZF Friedrichshafen AG. The merger was approved and subsequently consummated before the open on May 29, 2020. As a result, each existing WBC Common Share will be converted into the right to receive \$136.50 net cash per share.

Settlement in WBC1D futures will take place through OCC's cash settlement system.

Pursuant to Rule 1304 of OCC's Rules and Bylaws, the maturity date for all WBC1D Security Futures will be accelerated on May 29, 2020.
