The Options Clearing Corporation (OCC) has been informed that Apergy Corporation (APY) will change its name, trading symbol and CUSIP to ChampionX Corporation (CHX), CUSIP 15872M104. As a result, option symbols APY/2APY will also change to CHX/2CHX effective at the opening of business on June 4, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols CHX/2CHX commencing June 4, 2020.
