Era Group Inc. (ERA) has announced a 1-for-3 reverse stock split and a name/symbol/CUSIP change. As a result of the reverse stock split and name/symbol/CUSIP change, each ERA Common Share will be converted into the right to receive approximately 0.333333 (New) Bristow Group Inc. (VTOL) Common Shares. The reverse stock split and name/symbol/CUSIP change will become effective before the market open on June 12, 2020.

Until the cash in lieu amount is determined, the underlying price for VTOL1 will be determined as follows:

$VTOL1 = 0.333333 \text{ (VTOL)}$

DELAYED SETTLEMENT

The VTOL component of the VTOL1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the VTOL1 deliverable until the cash in lieu of

fractional VTOL Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
