The Options Clearing Corporation (OCC) has been informed that Extraction Oil & Gas, Inc. (XOG) will change its trading symbol to XOGAQ, effective June 25, 2020, due to the listing of the company on an OTC market. Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol XOGAQ commencing June 25, 2020.
