DELAYED SETTLEMENT

The FHN component of the FHN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FHN1 deliverable until the cash in lieu of fractional FHN shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

BACKGROUND

On April 24, 2020, Shareholders of Iberiabank Corporation (IBKC) voted concerning the proposed merger with First Horizon National Corporation (FHN). The merger was approved and consummated on July 1,

2020. As a result, each existing IBKC Common Share will be converted into the right to receive 4.584 FHN Common Shares. Cash will be paid in lieu of fractional FHN shares.
