The Options Clearing Corporation (OCC) has been informed that Catasys, Inc. (CATS) will change its name, trading symbol and CUSIP to Ontrak, Inc. (OTRK), CUSIP 683373104. As a result, option symbol CATS will also change to OTRK effective at the opening of business on July 7, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol OTRK commencing July 7, 2020.
