(RTW) will change its trading symbol to RTWI, effective July 7, 2020, due to the listing of the company on an OTC market. As a result, option symbol RTW will change to RTWI effective at the opening of business on July 8, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol RTWI commencing July 8, 2020.
