**SUBJECT: IBERIABANK CORPORATION - CASH IN LIEU SETTLEMENT
ADJUSTED OPTION SYMBOL: FHN1**

Iberiabank Corporation options were adjusted on July 2, 2020 (See OCC Information Memo #47243). The new deliverable became 1) 458 First Horizon National Corporation (FHN) Common Shares, and 2) Cash in lieu of 0.4 fractional FHN shares. Only settlement of the cash portion of FHN1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.73 per whole FHN share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.4 \times \$9.73 = \$3.89 \text{ per FHN1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 2, 2020 through July 14, 2020, to deliver the appropriate cash amount.

Terms of the FHN1 options are as follows:

New Deliverable Per Contract: 1) 458 First Horizon National Corporation (FHN) Common Shares
2) \$3.89 Cash

STRIKE PRICES: Unchanged

CUSIP: FHN: 320517105

MULTIPLIER: 100 (i.e., a premium of 1.50 yields \$150)

SETTLEMENT

The FHN component of FHN1 exercise/assignment activity from July 2, 2020 through July 13, 2020, has settled through National Security Clearing Corporation (NSCC). The \$3.89 cash amount will be settled by OCC.

PRICING

The underlying price for FHN1 options will be determined as follows:

$$\text{FHN1} = 4.58 \text{ (FHN)} + 0.0389$$

For example, if FHN closes at 8.90, the FHN1 price would be calculated as follows:

$$\text{FHN1} = 4.58 (8.90) + 0.0389 = 40.80$$
