SUBJECT: MOBILE MINI, INC. - CASH IN LIEU SETTLEMENT ADJUSTED OPTION SYMBOL: WSC1

Mobile Mini, Inc. options were adjusted on July 1, 2020 (See OCC Information Memo #47238). The new deliverable became 1) 240 WillScot Mobile Mini Holdings Corporation (WSC) Class A Common Shares, and 2) Cash in lieu of 0.5 fractional WSC shares. Only settlement of the cash portion of WSC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$13.732 per whole WSC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.5 x \$13.732 = \$6.87 per WSC1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 1, 2020 through July 15, 2020, to deliver the appropriate cash amount.

Terms of the WSC1 options are as follows:

New Deliverable Per Contract:	 240 WillScot Mobile Mini Holdings Corporation (WSC) Class A Common Shares \$6.87 Cash
STRIKE PRICES:	Unchanged
CUSIP:	WSC: 971378104
MULTIPLIER:	100 (i.e., a premium of 1.50 yields \$150)

SETTLEMENT

The WSC component of WSC1 exercise/assignment activity from July 1, 2020 through July 14, 2020, has settled through National Security Clearing Corporation (NSCC). The \$6.87 cash amount will be settled by OCC.

PRICING

The underlying price for WSC1 options will be determined as follows:

WSC1 = 2.40 (WSC) + 0.0687

For example, if WSC closes at 12.78, the WSC1 price would be calculated as follows:

WSC1 = 2.40 (12.78) + 0.0687 = 30.74
