California Resources Corporation (CRC) will change its trading symbol to CRCQQ, effective July 17, 2020, due to the listing of the company on an OTC market. As a result, option symbol CRC will change to CRCQQ effective at the opening of business on July 20, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CRCQQ commencing July 20, 2020.
