The Options Clearing Corporation (OCC) has been informed that Noble Corporation plc (NE) will change its trading symbol to NEBLQ, effective August 4, 2020, due to the listing of the company on an OTC market. As a result, option symbol NE will change to NEBLQ effective at the opening of business on August 5, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol NEBLQ commencing August 5, 2020.
