On August 14, 2020, Ferrari Merger Sub, Inc., an indirect wholly owned subsidiary of Ferrari Group Holdings, L.P., completed its tender offer for Forescout Technologies, Inc. (FSCT). The subsequent merger was consummated on August 17, 2020. As a result, each existing FSCT Common Share will be converted into the right to receive \$29.00 net cash per share.

Settlement in FSCT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Forescout Technologies, Inc. options whose expiration dates are after 8-21-2020 will have their expiration dates advanced to 8-21-2020. Expiration dates occurring before 8-21-2020 (e.g., Flex options) will remain unchanged.

All Forescout Technologies, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months
New expiration date: 8-21-2020

Existing American-style Forescout Technologies, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
