Capitala Finance Corporation (CPTA) has announced a 1-for-6 reverse stock split. As a result of the reverse stock split, each CPTA Common Share will be converted into the right to receive approximately 0.166667 (New) Capitala Finance Corporation Common Shares. The reverse stock split will become effective before the market open on August 24, 2020. Cash will be paid in lieu of fractional CPTA shares.

The CPTA component of the CPTA1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the CPTA1 deliverable until the cash in lieu of fractional CPTA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
