The Options Clearing Corporation (OCC) has been informed that Shiloh Industries, Inc. (SHLO) will change its trading symbol to SHLOQ, effective September 10, 2020, due to the listing of the company on an OTC market. As a result, option symbol SHLO will change to SHLOQ effective at the opening of business on September 10, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SHLOQ commencing September 10, 2020.
