On September 7, 2020, Shareholders of 58.com Inc. (WUBA) voted concerning the proposed merger with Quantum Bloom Company Ltd, a wholly-owned subsidiary of Quantum Bloom Company Ltd. The merger was approved and subsequently consummated on September 17, 2020. As a result, each existing WUBA American Depositary Share will be converted into the right to receive \$55.95 cash per share (\$56.00 less \$0.05 ADS Cash Distribution Fee), less withholdings, if any.

CONTRACT ADJUSTMENT

DATE: September 18, 2020

NEW DELIVERABLE
PER CONTRACT: \$5,595.00 Cash (\$55.95 x 100), less withholdings, if any

SETTLEMENT: OCC will delay settlement of WUBA deliverable until the final net cash merger consideration is confirmed. Once the final amount is determined, settlement in WUBA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23988)
