The Options Clearing Corporation (OCC) has been informed that Superior Energy Services, Inc. (SPN) will change its trading symbol to SPNX, effective September 18, 2020, due to the listing of the company on an OTC market. As a result, option symbol SPN will change to SPNX effective at the opening of business on September 18, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol SPNX commencing September 18, 2020.
