The Options Clearing Corporation (OCC) has been informed that Town Sports International Holdings, Inc. (CLUB) will change its trading symbol to CLUBQ, effective September 24, 2020, due to the listing of the company on an OTC market. As a result, option symbol CLUB will change to CLUBQ effective at the opening of business on September 25, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CLUBQ commencing September 25, 2020.
