Just Energy Group Inc. (JE) has announced an anticipated 1-for-33 reverse stock split, in conjunction with the Plan of Arrangement. As a result of the reverse stock split, each JE Common Share will be converted into the right to receive approximately 0.030303 (New) Just Energy Group Inc. Common Shares. The reverse stock split is anticipated to become effective before the market open on **September 29, 2020**. Fractional shares will be rounded down to the nearest whole share.
