**SUBJECT: ADJUSTED ADICET BIO, INC. - CASH IN LIEU SETTLEMENT
ADJUSTED OPTION SYMBOL: ACET1**

Adjusted Adicet Bio, Inc. (formerly resTORbio, Inc.) options were adjusted on September 16, 2020 (See OCC Information Memo #47584). The new deliverable became 1) 14 Adicet Bio, Inc. (ACET) Common Shares, and 2) Cash in lieu of approximately 0.2857 fractional ACET shares. Only settlement of the cash portion of ACET1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$14.98 per whole ACET share will be used to determine the cash in lieu amount at a rate of 0.2857. Accordingly, the cash in lieu amount is:

$$0.2857 \times \$14.98 = \$4.28 \text{ per ACET1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 16, 2020 through October 2, 2020, to deliver the appropriate cash amount.

Terms of the ACET1 options are as follows:

New Deliverable Per Contract: 1) 14 Adicet Bio, Inc. (ACET) Common Shares
2) \$4.28 Cash

STRIKE PRICES: Unchanged

CUSIP: ACET: 007002108

MULTIPLIER: 100 (i.e., a premium of 1.50 yields \$150)

SETTLEMENT

The ACET component of ACET1 exercise/assignment activity from September 16, 2020 through October 1, 2020, has settled through National Security Clearing Corporation (NSCC). The \$4.28 cash amount will be settled by OCC.

PRICING

The underlying price for ACET1 options will be determined as follows:

$$\text{ACET1} = 0.14 (\text{ACET}) + 0.0428$$

For example, if ACET closes at 12.21, the ACET1 price would be calculated as follows:

$$\text{ACET1} = 0.14 (12.21) + 0.0428 = 1.75$$
