SUBJECT: AKORN, INC. – CONTRACT ADJUSTMENT/ACCELERATION OF

**EXPIRATIONS**

On September 4, 2020, the United States Bankruptcy Court for the District of Delaware confirmed the Modified Joint Chapter 11 Plan of Akorn, Inc. and Its Debtor Affiliates ("Plan"). The Plan became effective on October 2, 2020. As a result, all existing Akorn, Inc. shares were canceled, and AKRXQ shareholders were entitled to receive an amount of cash equal to the Pro Rata portion of the Distributable Proceeds, if any.

The Pro Rata portion of the Distributable Proceeds amount has been determined to be \$0.00 Cash per AKRXQ share held. There will be no future distributions.

AKRXQ exercise and assignment activity, which was subject to delayed settlement from October 2, 2020 to December 2, 2020, is no longer subject to delayed settlement, effective December 3, 2020.

## **CONTRACT ADJUSTMENT**

The option symbol AKRXQ will not change.

In settlement of AKRKQ exercise/assignment activity, an AKRXQ put exerciser (or call assignee) will receive a cash payment of the full aggregate strike price amount on the exercise settlement date. An AKRXQ put assignee (or call exercise) will pay this amount on the exercise settlement date. Settlement will take place through OCC's cash settlement system on the second business day after exercise.

Since AKRXQ options are American-style, they are exercisable at the election of the holder. Expiration processing for AKRXQ options will take place in the normal fashion, including automatic exercise thresholds.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Akorn, Inc. options whose expiration dates are after 12-18-2020 will have their expiration dates advanced to 12-18-2020. Expiration dates occurring before 12-18-2020 (e.g., Flex options) will remain unchanged.

All Akorn, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: AKRXQ

Existing Expiration: All months New expiration date: 12-18-2020

Existing American-style Akorn, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
