The Options Clearing Corporation (OCC) has been informed that Baytex Energy Corporation (BTE) will change its trading symbol to BTEGF, effective December 4, 2020, due to the listing of the company on an OTC market. As a result, option symbol BTE will change to BTEGF effective at the opening of business on December 7, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol BTEGF commencing December 7, 2020.
