CME Group Inc. (CME) has announced a \$2.50 annual variable dividend per each CME Class A Common Share. Nasdaq Global Select has set December 24, 2020 as the ex-distribution date for this distribution.

NO CONTRACT ADJUSTMENT FOR THE CME DIVIDEND

Pursuant to Article VI, Section 11A of OCC's By-laws, OCC has determined that CME and 2CME options WILL NOT BE ADJUSTED FOR THE \$2.50 DIVIDEND. OCC has determined that the Cash dividend is an ordinary dividend as defined in the OCC By-Laws for which no adjustment should be made.

Interpretations and Policies .01 to Article VI, Section 11A of the OCC By-Laws states:

... cash dividends or distributions (regardless of size) by the issuer of the underlying security which the Corporation believes to have been declared pursuant to a policy or practice of paying such dividends or distributions on a quarterly or other regular basis will, as a general rule, be deemed to be ordinary cash dividends or distributions within the meaning of paragraph (c) of Section 11A.
