**SUBJECT: FOUNDATION BUILDING MATERIALS, INC. – ANTICIPATED CASH SETTLEMENT**

On November 14, 2020, LSF9 Cypress Parent 2 LLC, who hold shares representing approximately 52.3% of the voting power for Foundation Building Materials, Inc. (FBM), caused to be delivered to FBM written consent adopting and approving the Merger Agreement between FBM and a wholly-owned subsidiary of ASP Flag Intermediate Holdings, Inc., a subsidiary of funds sponsored by American Securities LLC. If the merger is consummated, each existing FBM Common Share will be converted into the right to receive \$19.25 net cash per share.

### **CONTRACT ADJUSTMENT**

**DATE:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the first quarter of 2021.

**NEW DELIVERABLE  
PER CONTRACT:** \$1,925.00 Cash (\$19.25 x 100)

Settlement in FBM options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
