On December 30, 2020, Shareholders of Tiffany & Co. (TIF) voted concerning the proposed merger with wholly-owned subsidiary of Breakfast Holdings Acquisition Corporation, a wholly-owned subsidiary of LVMH Moet Hennessy-Louis Vuitton SE. The merger was approved and subsequently consummated before the open on January 7, 2021. As a result, each existing TIF Common Share will be converted into the right to receive \$131.50 net cash per share.

## **CONTRACT ADJUSTMENT**

**NEW DELIVERABLE** 

PER CONTRACT: \$13,150.00 Cash (\$131.50 x 100)

Settlement in TIF options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series (See OCC Information Memo 23988). Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Tiffany & Co. options whose expiration dates are after 1-15-21 will have their expiration dates advanced to 1-15-21. Expiration dates occurring before 1-15-21 (e.g., Flex options) will remain unchanged.

All Tiffany & Co. options will utilize a \$.01 exercise threshold.

Option Symbol: TIF

Existing Expiration: All months New Expiration date: 1-15-21

Existing American-style Tiffany & Co. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
