The Options Clearing Corporation (OCC) has been informed that J.C. Penney Company, Inc. (JCPNQ) will change its name, trading symbol and CUSIP to Old Copper Company, Inc. (CPPRQ), CUSIP 679535104. As a result, option symbol JCPNQ will also change to CPPRQ effective at the opening of business on January 8, 2021.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CPPRQ commencing January 8, 2021.
