ProShares UltraShort Financials (SKF) has announced a 1-for-2 reverse stock split. As a result of the reverse stock split, each SKF share will be converted into the right to receive 0.50 (New) ProShares UltraShort Financials shares. The reverse stock split will become effective before the market open on January 21, 2021.
