ProShares UltraShort QQQ (QID) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each QID share will be converted into the right to receive 0.25 (New) ProShares UltraShort QQQ shares. The reverse stock split will become effective before the market open on January 21, 2021.
