The Options Clearing Corporation (OCC) has been informed that Bridge Bancorp, Inc. (BDGE) will change its name, trading symbol and CUSIP to Dime Community Bancshares, Inc. (DCOM), CUSIP 25432X102. As a result, option symbol BDGE will also change to DCOM effective at the opening of business on February 1, 2021.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol DCOM commencing February 1, 2021.
