On February 5, 2021, Cards Acquisition Inc., an indirect wholly owned subsidiary of Cards Parent LP, completed its tender offer for Collectors Universe, Inc. (CLCT). The subsequent merger was consummated before the open on February 8, 2021. As a result, each existing CLCT Common Share will be converted into the right to receive \$92.00 net cash per share.

**CONTRACT ADJUSTMENT**

NEW DELIVERABLE  
PER CONTRACT: \$9,200.00 Cash (\$92.00 x 100)

Settlement in CLCT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Collectors Universe, Inc. options whose expiration dates are after 2-19-2021 will have their expiration dates advanced to 2-19-2021. Expiration dates occurring before 2-19-2021 (e.g., Flex options) will remain unchanged.

All Collectors Universe, Inc. options will utilize a \$.01 exercise threshold.

Option Symbols: CLCT  
Existing Expiration: All months  
New expiration date: 2-19-2021

Existing American-style Collectors Universe, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
