On March 12, 2021, Teiripic Merger Sub, Inc., an indirect wholly owned subsidiary of Horizon Therapeutics Public Limited Company, completed its tender off for Viela Bio, Inc. (VIE). The subsequent merger was consummated before the open on March 15, 2021. As a result, each existing VIE Common Share will be converted into the right to receive \$53.00 net cash per share.

Settlement in VIE options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Viela Bio, Inc. options whose expiration dates are after 3-19-2021 will have their expiration dates advanced to 3-19-2021. Expiration dates occurring before 3-19-2021 (e.g., Flex options) will remain unchanged.

All Viela Bio, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Viela Bio, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
