Adjusted Apex Global Brands Inc. (adjusted option symbol APEX1) options were adjusted on September 2, 2020 (See OCC Information Memo #47523). The new deliverable for APEX1 became 10 Apex Global Brands, Inc. (APEX) Common Shares.

On March 31, 2021, Shareholders of APEX will vote concerning the proposed merger with Galaxy Apex Merger Sub, Inc., a wholly-owned subsidiary of Galaxy Universal LLC. If the merger is approved and consummated, each existing APEX Common Share will be converted into the right to receive \$2.00 net cash per share.

If and when the merger is approved and consummated, adjusted APEX1 options will be further adjusted as described below.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in the second quarter of 2021.

**New Deliverable  
Per Contract:** \$20.00 Cash (\$2.00 x 10)

Settlement in APEX1 options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
