Subject: Adjusted Direxion Daily Financial Bear 3X Shares - Cash In Lieu

Settlement

Adjusted Option Symbol: FAZ2

Adjusted Direxion Daily Financial Bear 3X Shares options were adjusted on March 2, 2021 (See OCC Information Memo #48243). The new deliverable became 1) 12 Direxion Daily Financial Bear 3X Shares (FAZ), and 2) Cash in lieu of 0.5 fractional FAZ shares. Only settlement of the cash portion of FAZ2 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$38.209292 per whole FAZ share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.5 \times $38.209292 = $19.10 \text{ per FAZ2 Contract}$ 

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 2, 2021 through March 16, 2021, to deliver the appropriate cash amount.

Terms of the FAZ2 options are as follows:

**New Deliverable** 

**Per Contract:** 1) 12 Direxion Daily Financial Bear 3X Shares (FAZ)

2) \$19.10 Cash

Strike Prices: Unchanged

**CUSIP:** FAZ: 25460E240

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The FAZ component of FAZ2 exercise/assignment activity from March 2, 2021 through March 15, 2021, has settled through National Security Clearing Corporation (NSCC). The \$19.10 cash amount will be settled by OCC.

## **Pricing**

The underlying price for FAZ2 will be determined as follows:

FAZ2 = 0.12 (FAZ) + 0.1910

For example, if FAZ closes at 34.10, the FAZ2 price would be calculated as follows:

$$FAZ2 = 0.12 (34.10) + 0.1910 = 4.28$$
