On December 23, 2020, Shareholders of SINA Corporation (SINA) voted concerning the proposed merger with New Wave MMXV Limited, a wholly-owned subsidiary of New Wave Holdings Limited. The merger was approved and subsequently consummated on March 22, 2021. As a result, each existing SINA Ordinary Share will be converted into the right to receive \$43.30 net cash per share.

## **CONTRACT ADJUSTMENT**

PER CONTRACT: \$4,330.00 Cash (\$43.30 x 100)

SINA options, which were subject to delayed settlement on March 23, 2021, are no longer subject to delayed settlement, effective March 24, 2021.

Settlement in SINA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SINA Corporation options whose expiration dates are after 4-16-2021 will have their expiration dates advanced to 4-16-2021. Expiration dates occurring before 4-16-2021 (e.g., Flex options) will remain unchanged.

All SINA Corporation options will utilize a \$.01 exercise threshold.

Existing American-style SINA Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
