On March 31, 2021, Shareholders of SMTX Corporation (SMTX) voted concerning the proposed merger with a wholly-owned subsidiary of EMS Silver Inc., an affiliate of H.I.G. Capital, LLC. The merger was approved and subsequently consummated before the open on April 5, 2021. As a result, each existing SMTX Common Share will be converted into the right to receive \$6.044 net cash per share.

PER CONTRACT:** \$604.40 Cash (\$6.044 x 100)

Settlement in SMTX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SMTX Corporation options whose expiration dates are after 4-16-2021 will have their expiration dates advanced to 4-16-2021. Expiration dates occurring before 4-16-2021 (e.g., Flex options) will remain unchanged.

All SMTX Corporation options will utilize a \$.01 exercise threshold.

New expiration date: 4-16-2021

Existing American-style SMTX Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
