Oaktree Strategic Income Corporation - Cash In Lieu Settlement Adjusted Option Symbol: OCSL1

Oaktree Strategic Income Corporation options were adjusted on March 19, 2021 (See OCC Information Memo #48459). The new deliverable became 1) 133 Oaktree Specialty Lending Corporation (OCSL) Common Shares, and 2) Cash in lieu of 0.71 fractional OCSL shares. Only settlement of the cash portion of OCSL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.70 per whole OCSL share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

0.71 x \$4.70 = \$3.34 per OCSL1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of March 19, 2021 through April 13, 2021, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the OCSL1 options are as follows:

New Deliverable Per Contract:	1) 133 Oaktree Specialty Lending Corporation (OCSL) Common Shares 2) \$3.34 Cash
Strike Prices:	Unchanged
CUSIP:	OCSL: 67401P108
Multiplier:	100 (i.e., a premium of 1.50 yields \$150)

<u>Settlement</u>

The OCSL component of OCSL1 exercise/assignment activity from March 19, 2021 through April 12, 2021, has settled through National Security Clearing Corporation (NSCC). The \$3.34 cash amount will be settled by OCC.

Pricing

The underlying price for OCSL1 will be determined as follows:

OCSL1 = 1.33 (OCSL) + 0.0334

For example, if OCSL closes at 6.49, the OCSL1 price would be calculated as follows:

OCSL1 = 1.33 (6.49) + 0.0334 = 8.67
