On February 24, 2021, Shareholders of Golar LNG Partners LP (GMLP) approved the proposed merger with Lobos Acquisition LLC, a wholly-owned subsidiary of New Fortress Energy Inc. If and when the merger is consummated, each existing GMLP Common Unit will be converted into the right to receive \$3.55 net cash per unit.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur on or about April 16, 2021.

**New Deliverable**  
**Per Contract:** \$355.00 Cash (\$3.55 x 100)

Settlement in GMLP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
